Amendments to Articles of Incorporation of Christian Business Owners / CEOs of Florida, Inc. N16000011438

Article IV is amended to read:

The directors of the corporation shall be elected or appointed as follows:

The initial Board of Directors shall be appointed by the Incorporator. Subsequently, the Board of Directors shall have the authority to elect members of the Board of Directors, who shall be elected annually to serve one year terms. If a vacancy shall occur on the Board of Directors, the vacancy may be filled by a majority of the Directors in attendance at a meeting of the Board called for such purpose.

The following additional Articles are incorporated into the Articles of Incorporation by amendment:

Article VIII

The Corporation shall not possess or exercise any power or authority, expressly, by interpretation, or by operation of law, that will prevent it at any time from qualifying and continuing to qualify as a political organization described in section 527 of the Internal Revenue Code, nor shall it engage directly or indirectly in any activity which would cause the loss of such qualification.

No part of the net income of the Corporation shall inure to the benefit of or be distributed to its directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services actually rendered and to make payments and distributions in furtherance of the purpose and objects set forth in this Article.

Article IX

The Corporation may be dissolved at any time by a majority vote of the Board of Directors of the Corporation who are in attendance at a meeting of the Board called for such purpose. Following such vote, the Board of Directors shall supervise the orderly dissolution of the organization, including the distribution of the remaining funds of the organization consistent with the purposes stated herein.

Upon dissolution of the corporation or the winding up of its affairs, the assets of the Corporation, if any, remaining after payment or provision for payment of all liabilities,

shall be distributed to one or more organizations that are exempt from taxation under section 527 and have purposes similar to those of the Corporation, or be distributed to one or more corporations that are exempt from taxation under section 501(c)(4) or section 501(c)(3) of the Internal Revenue Code.

Article X

The Corporation shall have no members.
