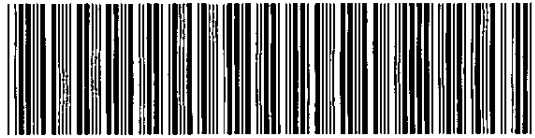

## ARTICLES OF INCORPORATION

### ARTICLE I

The name of this corporation is Discovery

Connections Inc

---

### ARTICLE II

This corporation is organized pursuant to the provisions of the General Nonprofit  
Corporation Law of the State of Florida

---

### ARTICLE III

The principal office for the transaction of business of this corporation is to be located in Orange  
County, Florida ,4799.Walden Circle suite74.Orlando ,FL ,32811

---

#### ARTICLE IV

The purposes for which this corporation is formed are exclusively charitable and educational and consist of the following:

- A. The specific and primary purposes are:
  - 1. To raise the economic, educational and social levels and enhance the quality of life of residents of Central Florida \_\_\_\_\_ especially those who are developmentally disadvantaged.
  - 2. To help people with development disabilities access the public and private sectors in order to obtain gainful and meaningful employment as well as self-sufficiency.
  - 3. To expand opportunities available to said residents to obtain adequate affordable housing accommodations by constructing, rehabilitating, developing, providing, and managing decent, safe, and sanitary housing.
  - 4. To promote cooperation and coordination among community organizations, and between community organizations and individuals, government agencies, and the private sector, in meeting the needs of said residents for jobs and decent, affordable housing, community facilities, and other services.

The general purposes and powers are to have and exercise all rights and powers conferred on corporations formed under the General Nonprofit Corporation Law of the State of Florida \_\_\_\_\_, provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the specific and primary purposes of this corporation.

#### ARTICLE VI

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or

the corresponding provision of any future United States Internal Revenue Law), or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.




#### ARTICLE VIII

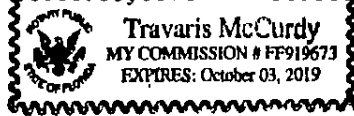


