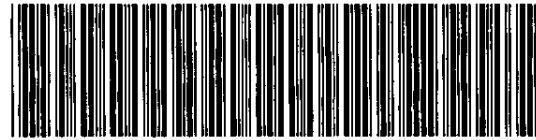

This Corporation is a non-profit religious benefit corporation and is organized to spread the gospel for Jesus Christ. 
