# **ARTICLE 1**

The name of the Corporation is TeachThemYoungER Inc.

# ARTICLE 2

#### **DURATION**

The duration of the corporate existence shall be perpetual commencing January 1, 2017.

## **ARTICLE 3**

#### **PURPOSE OF CORPORATION**

TeachThemYoungER Inc. is organized exclusively charitable, educational, and public benefit, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. TeachThemYoungER Inc. dedicated to bringing communities together to focus on the success of families and children. This grassroots movement will engage businesses, human service agencies, sports organizations, and parent groups to meet the needs of our communities, now and in the future.

#### **PURPOSE IN DETAIL**

Notwithstanding any other provisions of this document, TeachThemYoungER Inc. shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### LIABILITIES FOR DEBTS
