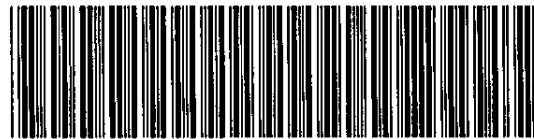



## **Articles of Incorporation of Florida Filmmakers' Showcase, Inc.**

The undersigned, who are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida do hereby certify:

**First:** The name of the Corporation shall be Florida Filmmakers' Showcase, Inc.

**Second:** The place in this state where the principal office of the Corporation is to be located is 3900 County Line Road, #15B, Tequesta, Florida, 33469, Palm Beach County.

**Third:** Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The specific purpose or purposes for which the corporation is organized is to produce micro-budget, independent films in Florida by Florida Filmmakers and provide a means by which Florida film school graduates can remain and produce films in an educational setting.

**Fourth:** The name and address of the person who is the initial trustee of the corporation is as follows:

Name: Frank Eberling Address: 3900 County Line Road, #15B, Tequesta, Florida 33469.

**Fifth:** Directors: Initially the Board of Directors will be recruited and appointed by the Incorporator. Two years after the effective date of incorporation, Board of Directors shall be elected by a majority of the then current Board of Directors for two year staggered terms.

**Sixth:** Initial Director/Officer: Frank Eberling, President and Director, 3900 County Line Road, #15B, Tequesta, Florida 33469.

**Seventh:** Registered Agent: Sheryl G. Wood, Esq., 515 N. Flagler Drive, Suite P300, West Palm Beach, Florida 33401.

**Eight:** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Ninth:** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding

section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Tenth:** The Incorporator is Frank Eberling. Address: 3900 County Line Road, #15B, Tequesta, Florida, 33469.

**Eleventh:** This document will become effective on the date of filing.
