

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

**Article I
Name**

The name of the corporation shall be Radharani Club, Inc.

**Article II

**Article III
Purposes**

The specific purposes for which the corporation is organized are:

- (a) To perpetuate the deity worship at the ISKCON of Alachua County, Inc. temple in Alachua, Florida, a temple of the International Society for Krishna Consciousness (ISKCON);
- (b) To provide funds for the purpose of maintaining and increasing the standard of worship for the Deities on the altar at the ISKCON of Alachua County, Inc. temple in Alachua, Florida, particularly at the time of religious holidays and festivals.
- (c) In furtherance thereof, the Corporation may receive property by gift, devise or bequest, invest and reinvest the same, and apply the income and principle thereof, as the Board of Directors may from time to time determine, either directly or through contributions to any religious organization or organizations, exclusively for religious purposes, and engage in any lawful act or activity for which corporations may be organized under the general laws of the State of Florida.

ARTICLE IX
Limitation of Corporate Powers

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes, unless limited as follows:

(a) This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) The corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible Section 170(c)(2) of the Internal Revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.

ARTICLE X
Distribution of Assets Upon Dissolution

The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or for the Corporation and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for religious purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.


