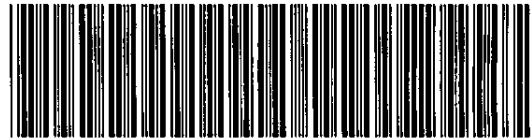

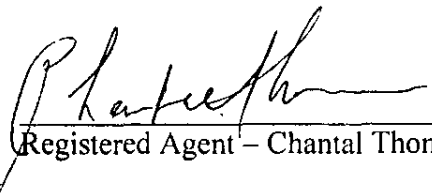

ARTICLE VIII- DISSOLUTION

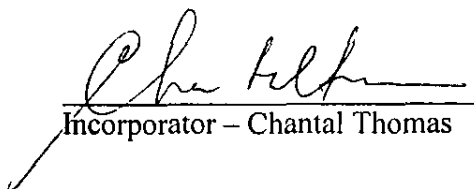
