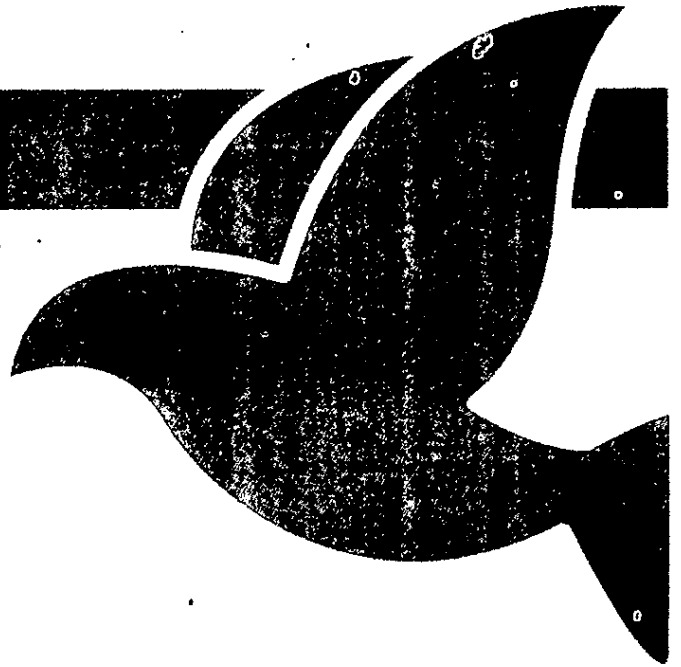

**ARTICLES OF INCORPORATION**

**FOR**

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of this corporation shall be: Agape Fellowship Baptist Church, Inc.

**ARTICLE II: PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS:**

**ARTICLE III: PURPOSE(S):**

The specific purpose(s) for which this corporation is organized is (are): to solicit, collect, accumulate, administer, receive and maintain real and personal property or both, in whatever form, include cash funds from public or private sources, and subject to the restrictions and limitations hereinafter set forth to use and apply the whole or any part of the income therefrom and principal thereof exclusively for religious, charitable, literary, scientific or educational purposes, either directly or by contributions to organization that qualify as exemption organizations under Section 501 (c) (3) of the Internal Revenue Code and the Regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

**ARTICLE IV: MANNER OF ELECTION OF DIRECTORS**

The manner in which directors are elected or appointed is as follows:

All directors must be members of Agape Fellowship Baptist Church. There election shall take place at a meeting called for that purpose, of which at least week's public notice has been given. An affirmative vote of three forth of those members will validate the choices. The Directors shall be replaced or elected for a new term at the annual election of officers of the corporation.

#### **ARTICLE V: LIMITATIONS OF CORPORATION POWERS**

The corporate powers of this Corporation are as provided in Section 617.0302 of Florida Statutes, unless limited as follows:

The corporation shall be empowered to enter into contracts, hold and covey title to real and personal property, and exercise all powers permitted a Corporation not for profit and the other laws of the State of Florida, not inconsistent with the general objectives enumerated herein. All funds of the Corporation and any moneys from its operation shall be used in the furtherance of the purposes set forth herein above.

No part of the net earnings of the Corporation shall insure to the benefit of or to be distributable to any director or officer of the Corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation in the furtherance of one or more purpose(s) and no director or officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding, any other provision of these Articles of Incorporation, the Corporation shall not conduct or carry on any activities not permitted to be conducted by an organization exempt from taxation under Section 501 (c) (3) of the Internal Revenue Code and the Regulations issued pursuant thereof as they exist or may hereafter be amended, or by an organization, contributions to which are deductible under Section 107 (c) (2) of the Internal Revenue Code and said Regulations as they now exist or as hereafter be amended.

#### **ARTICLE VI: DISSOLUTION OF ORGANIZATION**

Upon dissolution of the Church, the trustees shall, after paying or making provision for payment of all liabilities of the Church, dispose of all the assets of the Church to such organization(s) organized and operated exclusively for religious purposes as shall at the time qualify as an exempt organization(s) under Section 501(c) (3) of the Internal Revenue Code 1986 (or the corresponding provision of any future United States Law) as the trustees shall determine. Assets may be distributed to the Treasure Cost Baptist Association or other organization(s) which agree with the Church's Statement of Faith.

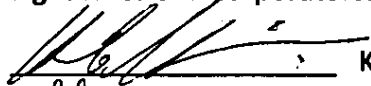

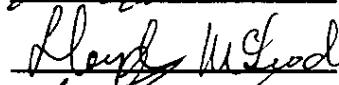

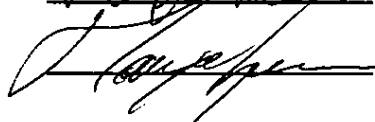
