

ARTICLES OF INCORPORATION

Article I NAME

The name of the corporation shall be Citizens Against Discrimination And Social Injustice, Inc.

Article II PRINCIPAL OFFICE

Article III PURPOSE

This corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The corporation is further organized to assure the rights of citizens of these United States, or residents therein are protected, afforded, granted and adhered to by all lawful and legal entities situated or occurring particularly in Pasco County, Florida or any other location or jurisdiction as the circumstances may warrant.
