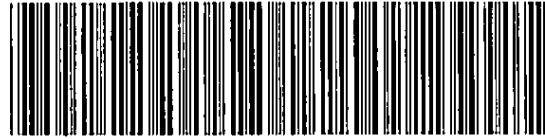

AMENDMENT
OF
THE ARTICLES OF INCORPORATION
OF
THE ALTINURE FOUNDATION, INC.

Pursuant to §§617.1002 and 617.1006 of the Florida Statutes, the Articles of Incorporation of The Altinure Foundation, Inc., a Florida not for profit corporation formed on December 20, 2016 (the "Corporation"), are hereby amended as follows:


1. Article I of the Corporation's Articles of Incorporation is hereby amended by deleting the existing Article I and substituting the following in lieu thereof:

"Article I – NAME: The name of the corporation (hereinafter referred to as the "Corporation") shall be: **The Hanrahan Foundation, Inc.**"

2. All other provisions of the Articles of Incorporation shall remain in full force and effect.

3. This Amendment of the Articles of Incorporation of the Corporation was duly adopted on June, 18, 2019 by the Corporation's Board of Directors. The Corporation has no members entitled to vote on the matter.
