Articles of Incorporation Of

Article 1.

The name of the corporation is Holistic Action For The Transformation Of Haiti, Inc.

Article 2.

The initial registered office of the Corporation shall be at: 1615 SE 20th Place, Homestead, FL 33035. The initial registered agent of the Corporation at such address shall be: Claude Jeudy.

Article 3.
