ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SPACE COAST SAILING EDUCATION FOUNDATION, INC.

These Articles of Amendment to Articles of Incorporation of SPACE COAST SAILING EDUCATION FOUNDATION, INC., are executed as of the property day of July, 2021.

- 1. The Articles of Incorporation were filed on December 27, 2016 and assigned document number N16000012233.
- 2. The Articles of Incorporation are hereby amended to provide as follows:

Article I is amended to read as follows:

The name of the corporation is Melbourne Sailing Education Foundation, Inc.

Article III is amended to read as follows:

a. The corporation is formed and shall be operated exclusively for charitable or educational purposes within the meaning of section 50l(c)(3) of the Internal Revenue Code and regulations issued pursuant thereto as they now exist or as may hereafter be amended. The primary objective of the MSEF shall be to promote and advance the sport of sailing including offering scholarships to allow deserving individuals, including youths, veterans, and the disabled to learn sail. The MSEF may also engage in other activities to educate the public about and advance the sport of sailing for the benefit of residents of the Space Court and surrounding areas.

)

- b. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- c. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to

influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

d. Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the corporation's liabilities, dispose of all of the assets of the corporation for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code (or the corresponding provisions of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any of such assets not disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as the Court shall determine, which are organized and operated exclusively for such purposes.

Article IV is amended to read as follows:

- a. The Board of Directors shall consist of five (5) members.
- b. The Melbourne Yacht Club, Inc. will select the Directors.
- 3. The Board of Directors approved the above amendment on July 14. 2021.
