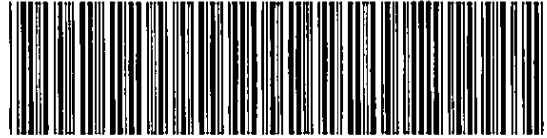

Article III is being amended in its entirety to read as follows:

---

This corporation is organized exclusively for charitable and religious purposes within the meaning of the Internal Revenue Code Section 501(c)(3) namely: to provide faith based assistance to disadvantaged addicts, recovering addicts and their families as well needy children and families in distress in South Florida and around the world who are struggling with life's challenges. This organization will provide spiritual counseling and referrals to medical treatment and rehabilitation. If needed, it will pay for treatment at recognized clinical facilities or cover other expenses. It will likewise assist poor children in receiving an education by providing educational supplies, wholesome food, clothing and other resources.

This corporation will operate ministry centers wherein will take place religious events, seminars, workshops, courses, and individual or group counseling to advance the above stated purposes. It will work together with social, religious and community organizations to identify families or individuals in distress. It is empowered to make direct cash grants when in the view of the directors, officers or staff, such grants are required to address or avert severe crises.

It will operate thrift stores to help fund its operations.

The following Article IX is being added at the conclusion of the Articles of Incorporation:

In the event of the dissolution of this corporation, the directors, after paying all outstanding debts, will distribute all remaining assets to other organizations recognized by the IRS under Sec 501(c)(3) with similar goals.
