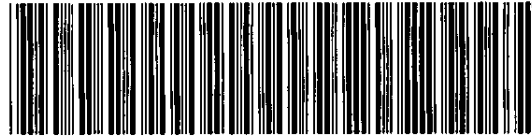

ARTICLE IX. DISSOLUTION

Section 10.1 Dissolution policy.
