ARTICLES OF INCORPORATION

OF

THE PRESERVE AT THE CAPE HOMEOWNERS' ASSOCIATION, INC.

In compliance with the requirements of Chapter 617, Florida Statutes, the undersigned incorporator this day voluntarily adopts the following Articles of Incorporation for the purpose of forming a Florida not-for-profit corporation.

ARTICLE I

NAME

The name of the corporation is The Preserve at the Cape Homeowners' Association, Inc. (hereinafter referred to as the "Association").

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III

REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE V

MEMBERSHIP
