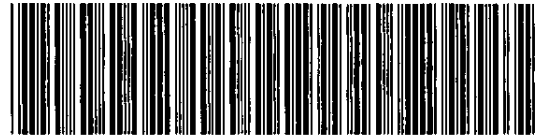

**Amendment to Name:** Article I of the Articles of Incorporation is hereby amended to read as follows:


