Please be advised by this letter that we have only recently become aware that our corporation is under Administrative Dissolution for failure to send you an Annual Report for 2003. An end of year audit of our checking account showed that we did not issue a check to renew our corporation last year.

Our on-line research found that you do not have a current list of officers or current mailing address. Listed is Annie Boquet who was a member and used her address at 12711 Marjory Avenue, Tampa, FL 33612 since 1997. Obviously, there was a failure to update that information after she resigned from our organization and moved out of state last year. The new officers did not know who received the bill, they just assumed the previous years treasurer would receive it and present it for payment at the proper time. Unfortunately we did not receive the bill and it was simply forgotten until the financial audit.

Since we do wish to rectify this error at this time, we are enclosing our check in the amount of \$122.50 to cover 2003 and the current year of 2004 along with a Corporation Reinstatement form listing current officers and mailing information. Since we are not paid for our efforts and are strictly volunteers hoping to help those less fortunate than ourselves we ask you to forgive any and all penalties.
