AMENDMENT TO ARTICLES

Article III is amended to read as follows:

ARTICLE III: PURPOSES

This organization is organized and shall be operated exclusively for charitable and educational purposes within the meaning of section 501{c}(3) of the Internal Revenue Code 1954.

1. This corporation is organized and operated exclusively for educational and other nonprofit purposes, and no part of any net earnings shall inure to the benefit of any member, director or officer.

2. This corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida, provided, however, that this corporation is not empowered to engage in any activity that in itself is not in furtherance of its purposes as set forth above.

Article XIV is hereby added:

ARTICLE XIV: DISSOLUTION

If THE WOMEN OF SUGARMILL WOODS, INC. dissolves the Board shall, after paying or making provisions for the payment of all liabilities of the organization, dispose of all the assets of the organization exclusively for the purposes of the organization in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501{c}(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) as the Board shall determine. Any such assets not so disposed of shall be disposed of by the court of jurisdiction of the county in which the principle office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
