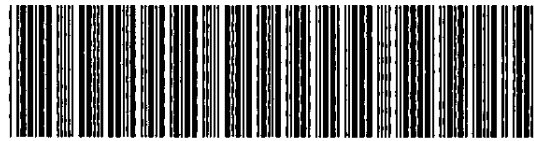

The undersigned, for the purposes of forming a Not for Profit Corporation under Section 617 of the Florida Statutes, does hereby certify as follows:

ARTICLE I

Corporate Name and Address

The name of the Corporation is Joy Olivia Ministries, Inc. The principal street address of the Corporation is 5612 Amoroso Drive, Fort Myers, FL 33919, and the mailing address of the Corporation is Post Office Box 2160, Fort Myers, Florida 33902.

ARTICLE II

Corporate Purpose

The Corporation is organized as a Not for Profit Corporation committed to helping others in need around the world. Notwithstanding any other provision of these articles, the Corporation shall not carry on any activities which are not permitted for a Corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code.

ARTICLE III

Registered Office and Registered Agent

The street address of the initial registered office of the Corporation in the State of Florida shall be 5612 Amoroso Drive, Fort Myers, FL 33919. The name of the initial registered agent of the Corporation at the registered office shall be Philip Youngblood.

ARTICLE IV

Manner of Election of Board of Directors

The initial Board of Directors of the Corporation shall be comprised of two people. The Directors shall be elected annually by the Board of Directors for a period of one (1) year. The number of Directors may be increased or decreased from time to time, but shall never be less than one. Commencement of Existence


The Corporation shall be deemed to commence on the date of filing of the Articles of Incorporation.
