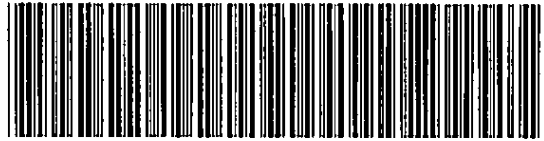

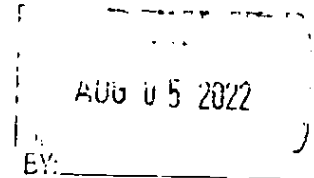



Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation CARING HAIR FOUNDATION, INC. N17000000193 adopts the following amendment(s) to its Articles of Incorporation:

Amending name, enter the new name of the corporation:

JUNETEENTH MUSIC ENTERTAINMENT, INC.

Amending Articles as follows:

**ARTICLE I
NAME**

The name of the corporation shall be JUNETEENTH MUSIC ENTERTAINMENT, INC.

**ARTICLE IV
PURPOSES AND POWERS OF CORPORATION**
