Article 1.

The name of the corporation is Mizuno Prime, Inc.

Article 2.

The initial registered office of the Corporation shall be at: 7008 Chesapeake Cir, Boynton Beach, FL 33436. The initial registered agent of the Corporation at such address shall be: Sath Washington.

Article 3.
