Pursuant To Florida Statutes Chapter 617.0202, the undersigned subscriber to these articles of incorporation, a natural person over the age of 18, competent to contract, herby forms a Florida nonprofit corporation.

ARTICLE I Name

The principle place of business and the mailing address of this corporation shall be:



Article III General Purpose

The purpose for which this corporation is organized is exclusively for charitable activities as defined under the Internal Revenue Code; Section 501C3 is to provide a feeding program and supplemental activities for applicable populations of individuals in need.
