ARTICLES OF INCORPORATION
OF

In compliance with Chapter 617, F. S. (Not for Profit)

ARTICLE I. – NAME

The name of the corporation shall be Ladies of the Dove, Incorporated.

ARTICLE II – PRINCIPAL OFFICE
