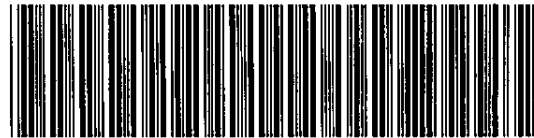

**ARTICLE I – NAME**

The name of the corporation shall be **SRQ Ladybugs, Inc.**

**ARTICLE II – PRINCIPAL OFFICE**

**ARTICLE III – PURPOSE**

- A. Purpose: The SRQ Ladybugs, Inc. is a chapter of the Ninety-Nines, Inc., an international organization of women pilots that promotes advancement of aviation through education, scholarships, and mutual support while honoring our unique history and sharing our passion for flight. The object and purpose of the corporation shall be to engage in strictly educational, charitable and/or scientific activities and purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- B. In the event of a dissolution of this corporation, the Board of Directors of The Ninety-Nines, Inc., a 501(c)(3) organization, shall have the power to dispose of the total assets of this corporation by a majority vote, provided that the distribution shall be for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

#### **ARTICLE IV – MANNER AND ELECTION**

The manner which the directors and officers are elected shall be provided in the By-Laws.
