ARTICLE 7: PRINCIPLE MAILING ADDRESS A

Section 1. The mailing address for How Will They Know Ministries shall be 424 Primrose Circle Destin, Florida 32541

Section 2: How Will They Know Ministries may also have subordinate offices as such other places both within and without the state of Florida and/or Internationally, as How Will They Know Ministries Board of Directors may deem necessary to fulfill the purposes of this organization. The How Will They Know Ministries Board of Directors may also determine to relocate How Will They Know Ministries headquarters from Destin, Florida in the United States of America, and/or Internationally to better fulfill the purposes of this organization.

ARTICLES 8: PROHIBITED ACTIVITIES (Add) please

Section 1. No part of the net earnings of How Will They Know Ministries shall inure to the benefit of, or distributable to, its Board Members, Officers, or other private persons, except that How Will They Know Ministries shall be authorized and empowered to pay compensation and love offerings as part of the compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 11 thereof only if resources are available. Except as provided in Section 501(h) or the corresponding provision of any future United States Internal Revenue Law, no substantial part of activities How Will They Know Ministries shall be the carrying on of propaganda, or otherwise attempting to influence legislation.

ARTICLE 10: MEETINGS (Add) please

Section 1. Annual meeting will be held June 1st of each year. Decisions will be determined by a quorum 3 out of 7 members voting. A report of the finances of How Will They Know Ministries shall be presented at that time, as a preliminary review, prior to the completed fiscal year end certified public accountant audit.

Section 2. The means of calling meetings can be, but not limited to: telephone, mail, email, and in person.

Section 3. Notification of meetings will be given two weeks in advanced to all the Board of directors.

Section 4. Notice of date, time, and place will be included in the notification of meeting, by telephone, mail, email, and in person.

Section 5. Participation in meetings by conference telephone. How Will They Know Ministries Board may participate in a meeting through the use of a conference telephone call or similar communication equipment, so long as all members participating in such meetings are able to hear one another., and such participation shall constitute presence in person at the meeting. No telephone meeting of How Will They Know Ministries Board shall take place without the President.

Section 6. A How Will They Know Ministries Board Member shall be dismissed during their tenure of service if they voluntary resign from the Board. If the How Will They Know Ministries Board Members unanimously or the President, individually determines removal at any special meeting duly called and held for such purpose: that the How Will They Know Ministries Board member does not faithfully and/or satisfactorily perform their Board position.

Section 7. The General Secretary and assistants shall be responsible to record, or cause to be recorded, and to keep, or cause to be kept, at the principal office or such other place as the Board may direct, a book of the minutes of all the business meetings, called by the President. The General Secretary and assistants are accountable to the Board. Specific duties are taking minutes, custodian of records,

Partner records, bylaw records, and communications records for all forms of communication.

ARTICLE-11: PURPOSES //

Section 1. The purposes for which the said How Will They Know Ministries Corporation is organized for religious, educational, charitable and humanitarian purposes, as may qualify it as exempt from Federal Income Tax under Section 501(c) (3) of the Internal Revenue Code in the State of Florida, or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE 12: PROPERTY (Add) Please

Section 1. To have the right to buy, take, lease or otherwise acquire, own, hold in trust, use, sell, convey, mortgage, lease, or otherwise dispose of such property, real, personal and mixed, tangible and intangible, of whatsoever in as may useful for the prosecution of this work.

Section 2. All property of How Will They Know Ministries, whether real of chattel shall be contracted for, purchased, received, or held in the corporate name of How Will They Know Ministries.

Section 3. No property of How Will They Know Ministries shall be sold, leased, or mortgaged or otherwise disposed of without the same shall have first been a duly authorized decision of How Will They Know Ministries Board subject to the final approval of President Evangelist Gina Marie Moore at a regular meeting or special meeting of the Board called for that purpose.

ARTICLE 13: IDEMNIFICTION (Add) Please

Section 1. How Will They Know Ministries does indemnify any directors, officers, employees, and incorporators, from any liability regarding How Will They Know Ministries and the affairs of How Will They Know Ministries unless the person fraudulently and intentionally violated the law and/or maliciously

conducted acts to damage and/or defraud How Will They Know Ministries, or as otherwise provided under applicable statute.

ARTICLE: 14: DISTRIBUTIONS UPON DISSOLUTION (Add) Please

Section 1. All liabilities and obligations of How Will They Know Ministries for distribution of assets on dissolution or final liquidation concerning the remaining assets of the How Will They Know Ministries shall be applied and distributed in the following manner:

- 1. All liabilities and obligations of How Will They Know Ministries shall be paid, satisfied, and discharged, or provisions shall be made therefore; any assets held on the condition they be returned, transferred or conveyed upon dissolution shall be disposed of in accordance with such requirements.
- 2. All remaining assets of every nature and description shall be distributed at the decision of a quorum of the Board and ratified by the President to one of more ministries, funds, or foundations, either at home and or abroad, whose purposes are considered nearest those of religious, educational, charitable, or humanitarian purposes. Qualified for exemption from tax under the Internal Revenue Code, or its successor provisions.

ARTICLE 15: Amendments (Add) Please

Section 1. These Bylaws may be altered, amended, and supplemented, superseded, or repealed and new Bylaws adopted by unanimous action at a regular or special meeting of the How Will They Know Ministries Board to be called by the President/Founder Evangelist Gina Moore for that purpose, so long as they are not inconsistent with the provisions of the Articles of Incorporation. Upon adoption by the How Will They Know Ministries Board and final approval President/Founder Gina Moore, the Amendments shall become effective.

Article 16: EFFECTIVE DATE

Section 1. These Bylaws shall become affective immediately following their adoption by President/Founder Gina Moore, and immediately following their adoption by the How Will They Know Ministries Board. The effective date of incorporation shall be: upon filing by the Secretary of State.
