ARTICLES OF INCORPORATION OF STANTON ESTATES HOMEOWNERS ASSOCIATION, INC., A FLORIDA NOT FOR PROFIT CORPORATION

ARTICLE I NAME

The name of this corporation shall be STANTON ESTATES HOMEOWNERS ASSOCIATION, INC. (the "Association").

ARTICLE II DURATION

Existence of the Association shall commence with the filing of these Articles of Incorporation ("Articles") with the Florida Department of State Division of Corporations. The Association shall have perpetual existence.

ARTICLE III PURPOSE AND POWERS OF THE ASSOCIATION

The Association is organized for the purpose of enforcing, and fulfilling the objectives and purposes stated in the "Governing Documents" (as that term is defined in that certain Declaration of Covenants, Conditions, Easements, and Restrictions for Stanton Estates, as same may from time to time be amended or supplemented (the "Declaration"), to be recorded in the Public Records of Orange County, Florida). Capitalized terms used above or herein without definition shall have the same meanings given or ascribed to such terms in the Governing Documents. of the City of Winter Garden, and shall assist in the enforcement of the restrictions and covenants contained herein.

Powers

Dissolution Language
