AMENDMENT TO ARTICLES OF TNT4KIDS, INC

Amendment to Articles of Incorporation Article III

The specific purpose for which this corporation is organized is:

To make charitable, educational, and scientific contributions to students, parents, and the community at large. This includes distributing donations and goods to other exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section(s) of any future tax code.

Upon the dissolution of the organization, assets shall be distributed to one or more exempt organizations as described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section(s) of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose in accordance with the values of the organization. Any such assets not disposed of will be disposed of by a court with appropriate jurisdiction within the county in which the principal office of the organization located. Assets distributed by the courts shall go exclusively to such organization(s) and/or purposes as the court determines.
