ARTICLES OF INCORPORATION OF EVERY MEAL MATTERS FOUNDATION, INC.

ARTICLE I NAME

The name of this corporation is EVERY MEAL MATTERS FOUNDATION, INC.

ARTICLE II DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III PURPOSE

The purpose for which this corporation is organized as all non-profit purposes permitted under 26 U.S.C. \$501(c)(3). Specifically, but not limited, this corporation will be involved in seeking solutions for malnutrition in children worldwide with the final goal of allowing them to improve their learning capacity for their future personal growth and development. It will also be involved in gathering and providing nutritious meals and necessary resources for the most susceptible children to improve their education and aid in their future development and growth.

ARTICLE IV CAPITAL STOCK

This corporation shall issue no stock.

ARTICLE V LOCATION

The Street, Address, City, County and State in which the principal offices of the corporation are to be located are 1948 NW 82nd Avenue, Miami, Miami-Dade County, Florida 33126. The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it may see fit.

ARTICLE VI INITIAL BOARD OF DIRECTORS

This corporation shall have six (6) Directors initially. The number of Directors may be increased or diminished from time to time in accordance with By Laws adopted by the members. ARTICLE VIII AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, and approved by the majority of the members at a General Assembly meeting, unless all the Directors sign a written statement manifesting their intention that a certain amendment to these Articles of Incorporation is made.

ARTICLE IX LIMITATIONS

- 1. No part of the net earnings of this corporation shall inure to the benefit of or be distributed to its members, directors, officers or other private person except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article.
- 2. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements.
- 3. No withstanding any other activities not permitted to be carried on by a corporation exempt from federal income tax under \$501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law, or by a corporation, contributions to which are deductible under \$170(c)(2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE X DISSOLUTION

On the dissolution of this corporation, the board of directors dispose of all of the assets of this corporation exclusively for the purposes of this corporation in the manner of the organizations that are organized and operated exclusively for charitable, educational, religious or scientific purposes and that shall at the time qualify as exempt organizations under \$5.01(c)(3) of the Internal Revenue Code of 1954 corresponding provision of any future United States Internal Revenue law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is then located exclusively for the purpose or to the organizations that the court determines are organized and operate exclusively for charitable, educational, religious or scientific purposes.

ARTICLE XI MEMBERS

The qualifications for and manner of admission of members shall be regulated by the bylaws.

ARTICLE XII INITIAL REGISTERED OFFICE AND AGENT

The Street address of the initial registered office of this corporation is 8567 Coral Way #303, Miami, Miami-Dade County, Florida 33155 and the name of the initial registered agent of this corporation at that address is Jorge A Chirinos.

ARTICLE XIII BYLAWS

The bylaws of the corporation shall be adopted by the board of directors.
