

ARTICLES OF INCORPORATION (Not for Profit) OF

Tvunot, Inc.



Article I - Name

The name of the Corporation shall be Tvunot, Inc.

Article II - Principal Office

The physical address of the corporation shall be:

4390 N. Michigan Avenue Miami Beach, Florida 33140

The mailing address of the corporation shall be:

168 North crest Lakewood, NJ 08701

Article III - Purpose

The specific purpose for which this Corporation is organized is to raise funds from private sources in Florida and other regions of the United States to support the charitable activities of an organization in Israel known as, "Project Tvunot, Inc." Project Tvunot, Inc. (the "Israeli Organization") is a recognized charitable organization under the laws of the State of Israel, and will be the exclusive recipient of the funds raised by this Corporation.

The funds raised by the Corporation will be solely dedicated to support the mission and activities of the Israeli Organization. The Israeli Organization's overall mission is to help children and families in Israel grapple with every day challenges and crises. This Corporation acknowledges that families in Israel often face difficult emotional, educational, and domestic issues. Many of these families are new immigrants who must adjust to a new society with a different language, culture and values. The Israeli Organization, in its effort to assist these families in Israel, provides active support in the following general areas: (i) systematic intervention for children and families who face educational, emotional and domestic issues; (ii) assistance to new immigrant families in respect to pre-Aliyah and post-Aliyah issues; (iii) gives support and immediate guidance to families faced with trauma related crisis including coordination and overseeing the treatment process for sexual and other abuse victims, and further guides these victims and their families during the treatment and rehabilitation process; (iv) educates the public on adapting personal safety measures against harmful individuals and molesters; and (v) raises awareness in the community on pressing issues which challenge Israeli society.

The Israeli Organization requires a sufficient and continuous flow of funds in order to successfully carry out the above stated activities for the benefit of low income and vulnerable Israeli and/or new immigrant families in Israel. Accordingly, this Corporation will exist in order to assure that funds are

raised in America (predominantly from private sources) to strengthen the financial well-being of the Israeli Organization, thus assuring that its critical mission in Israel is carried out successfully.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Article IV - Manner of Election

The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.
