## Articles of Incorporation of

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: The eventual outcome will be the establishment of a broader church ministry, that helps, counsels, assist, educate, etc. married, engaged and singles on biblical marriage and practical ways living our the scriptures as husband and wife. Our vision is "Your Marriage Is Your 1st Ministry" We are educators with the ability to provide spiritual counseling and practical education through our teaching ministry in our community.
