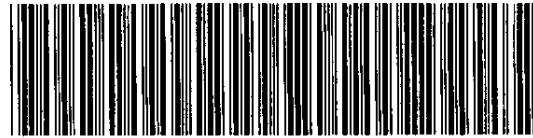

CHARTER  
OR  
ARTICLES OF INCORPORATION  
OF

Iglesias Pentecostal Subiendo Al Aposento Alto, Inc.

(NOT FOR PROFIT)

We the Undersigned personal of state Florida all of whom are of legal age, each being competent to contract, hereby from ourselves and our successor into a corporation not for profit under the Law of the State of Florida, and adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of this corporation shall be: Iglesias Pentecostal Subiendo Al Aposento Alto, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 14032 Higgins St. Spring Hill, Florida 34609 Country of Hernando, State Florida.

ARTICLE III PURPOSES

The general nature, object and purpose of this corporation is as follows:

A. The main and specific purposes for which this corporation is formed are to maintain and operate a religious corporation and to propagate and disseminate the religious principles that comprise: Iglesias Pentecostal Subiendo Al Aposento Alto, Inc.

B. The general purposes and objects for which this corporation is formed are to operate exclusively for charitable, religious and educational measures, to include but not limited to the following:

1. Establish, maintain and conduct an appropriate organization to oversee the affairs of this corporation.
2. To license and ordain ministers of the Gospel and missionaries to advance the work of this corporation in the United States and all other foreign countries, according to the regulations to be promulgated by the Board of Directors.
3. Assist in the establishment and / or give the corporation of churches or religious bodies for the dissemination and propagation of the Gospel of Jesus Christ in the United States and other foreign countries, such churches and entities subject to the articles and bylaws established by the corporation: Iglesias Pentecostal Subiendo Al Aposento Alto, Inc.
4. To establish, own and operate schools at the university level or a lower level.
5. Establish, maintain and conduct outreach efforts to advance the gospel in the United States and all foreign countries, pursuant to regulations promulgated by the Board of Directors.
6. Make any and all actions or things necessary, appropriate or desirable for the Compliance with any purpose or to achieve one or more objectives specified herein or that at any time appear conducive to that, or dossiers for that, if not Inconsistent with provisions or any law that may apply to the fulfillment of such Achievement of the purposes or objectives.

C. It is intended that the foregoing objects and purposes of this article shall not unless Specify here, will in no way limited or restricted by reference or inference from the terms of any provision of this or any other item in these articles of incorporation, but the objects and purposes specified in these items will be taken a statement from general objects and purposes and not intended to limit the activities of this corporation as charitable, religious and educational.

#### ARTICLE IV DIRECTORS / OFFICERS MANNER OF ELECTION

The officers in charge of managing the affairs of this corporation shall be as follows: President (Pastor) Secretary, Treasurer and the Deacons. The President shall be appointed by Iglesias Pentecostal Subiendo Al Aposento Alto, Inc. The president shall hold office until otherwise directed by the above mention councils. The secretary, treasurer, and deacons shall be elected by due process of general election. Candidates shall be selected from among the members of the corporation who qualifies for election as designated by the corporation's bylaws. Elections are to be held annually and every active member of the corporation has the right to vote. One the persons to hold these positions have been elected by vote majority, they shall hold office until their new successor has been elected and qualified.

#### ARTICLE V NO FINANCIAL PROFIT OR MONETARY GAIN

Iglesias Pentecostal Subiendo Al Aposento Alto, Inc. Is not organized, or be operated for profit or pecuniary gain, and includes the distribution of goods, or dividends to members, as this organization are formed non-profit. The property, assets, and net earnings of this corporation are irrevocably dedicated to religious, scientific and charitable and any gain or net inflow of this corporation shall be to the advantage or benefit of any director, officer, and member or for the benefit of private shareholders or individuals. With the dissolution or closing liabilities of the corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for religious, charitable, scientific or which has established its tax exempt status under Section 23701 (d) of the Code of Internal Taxes. If this corporation has any assets in deposits, such property shall be distributed according to the decrees of the Superior Court of the County within which the principal office of this corporation is located, at the request for that at the attorney general or by any person interested in the settlement.

#### ARTICLE VI LIMITATION OF ACTIVITIES

Iglesias Pentecostal Subiendo Al Aposento Alto, Inc. Did not conduct propaganda as a substantial part of its activities, or attempt in any way influence the legislation. This corporation shall not participate in or intervene in (including publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

#### ARTICLE VII POWERS

Iglesias Pentecostal Subiendo Al Aposento Alto, Inc. Will and exercised all the rights and powers conferred on corporations under the laws of the State of Florida, provided that this corporation has no authority to engage in any activity other than to advance objects and purposes set forth in Article III

Membership shall be open to anyone willing to comply with the corporation bylaw, however, neither the incorporates nor the members shall have any vested right, interest, or privilege of, in or assets function, affair or franchises of this corporation, or any right, interest or privilege which may be inheritable, or shall continue after his/she membership ceases in the forenamed corporation. The corporation shall not have the power to buy, mortgage sell encumber of deed or dispose of any property which it may acquire, without the consent or the direction of two-thirds (2/3) majority vote of the members, or its successors. The President shall sign and the secretary shall attest all legal contracts authorized by the members of this corporation and of the State of Florida.

#### ARTICLE XII PROPERTY

The Corporation shall have the power to buy, acquire, and hold title in fee simple, in trust, or otherwise to both real and personal property, and improve, encumber, sell convey and dispose of such property, to borrow money, execute note bonds and other evidences of indebtedness and to secure the same by mortgage and deeds of trust, annuity bonds, and other instruments of indebtedness and to pay interest thereon, to improve, adapt and use property held by it for, the said corporation or the income there from in the religious, education, benevolent, or social activities of the said corporation without financial profit to its members except as may be necessary in the payment of salaries, or other compensation for service rendered, and the corporation shall have the power to erect and to build and maintain residence for the use and occupancy of the ministers of the said corporation, not for profit under the laws of the State of Florida.
