1. Amend Article III (Purpose) to read: The Citrus Trails Alliance Corp is formed for educational and charitable within
he meaning of Section 501 (c) (3) of the Internal Revenue (IRS) Code of the US Govt (USG). These purposes include, but
are not limited to, informing people about significant conditions and issues on the hiking, biking, birding and paddling trails
of Citrus County, FL. The goal is to develop and encourage collaboration between all trail use organizations in and around
Citrus County.
2. Renumber Article IV to become Article V. Add a new Article IV which reads: NOT-FOR-PROFIT: The Citrus Trails
Alliance (CTAC) may sollicit, receive, purchase and borrow, with or without security, real and personal property - including
funds by way of gifts, contributions and subscriptions and administer, own, hold, convey, transfer, disburse, lend or sell the
same for such charitable and educational purposes as permitted by sections 501 (c) (3) of the IRS Code of the USG.
No asset of CTAC shall inure to the benefit of any private individual. CTAC shall not afford any pecuniary gain or profit
to its Directors or its members.
CTAC shall not conduct propaganda or any information activities aimed at influencing legislation at any level, nor shall it
participate in any political campaign of any candidate for public office.
Upon a dissolution of CTAC, any remaining assets shall be transferred to The Florida Trail Association, Inc., Rails-to-
Trails of the Withlacochec, Inc or any organization having purposes permitted under Section 501 (c) (3) of the IRS Code
of the USG - as deemed appropriate by a majority vote of the CTAC Board of Directors.
