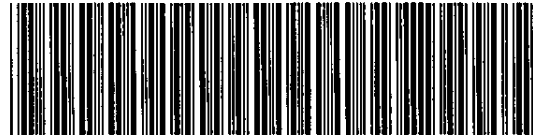


The enclosed Articles of Incorporation and fee(s) are submitted for filing. A copy of the Bylaws is also included for your files.

**ARTICLES OF INCORPORATION
OF
INTERFAITH ACTION GROUP OF SOUTHWEST FLORIDA, INC.**

ARTICLE I - NAME

The name of this Corporation shall be Interfaith Action Group of Southwest Florida, Inc. This Corporation shall be a not for profit corporation, organized in accordance with the provisions of the Florida Not for Profit Corporation Act, Chapter 617, Florida Statutes.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The Directors of this Corporation shall be elected as provided for in the Bylaws of the Corporation.




