



**ARTICLES OF INCORPORATION
IN COMPLIANCE WITH CHAPTER 617, F.S., (NOT FOR PROFIT)**

ARTICLE I - NAME

The name of this corporation is, and shall be, **STEP FORWARD CLUB, INC.**

ARTICLE II - PRINCIPAL OFFICE

The initial principal street address and mailing address of **STEP FORWARD CLUB, INC.**

(**"Club"**) is 229 Brazilian Circle, Port St. Lucie, Florida 34952.

ARTICLE III - PURPOSE

The Club is organized as a non-profit, incorporated entity to provide support and activities at a selected facility where registered 12 step groups may hold meetings, events and other activities; the facility may be opened at scheduled or unscheduled times to provide a place of fellowship where Members can come for social purposes outside of regular meeting times. The Club intends to meet the prerequisites of filing, and will file to qualify as a 501(c)(3) charitable organization.

ARTICLE IV - MEMBERSHIP AND DUES

All persons seeking the support through participation at the Club may be admitted to membership. They must be:

- (i) active in a 12 step program; and
- (ii) willing and able to follow all Club rules; and
- (iii) willing to agree to pay dues and to keep the same current at all times.

Annual dues shall be initially established by the Board of Directors, and such dues shall continue until changed by a majority vote of the Members at a monthly Club meeting. Dues shall be payable monthly, and continued membership shall be contingent upon current payment.

ARTICLE VI - MANNER OF ELECTION OF DIRECTORS AND OFFICERS

The number of Directors shall be not less than five (5), nor more than nine (9), and they shall be elected annually by vote of the general membership at a meeting held for that purpose. Upon their election, the Directors shall designate among themselves the officers specified in the preceding Article V. Directors, *ex officio*, shall serve as the officers of the Club.

ARTICLE VII - MEMBER VOTING

Each Member shall have one (1) vote upon matters requiring the taking of votes at Club meetings held for elections or the discharge of regular business.

ARTICLE VIII - RESIGNATION OF MEMBERS

Any Member may resign from membership by written resignation submitted to the Club Secretary. Default in payment of dues shall result in resignation without action of the Member. The membership of any person may be terminated by majority vote of the membership.

ARTICLE IX - MEETINGS OF MEMBERS

The time and place of annual and regular meetings of the membership and the requirements of notice thereof shall be as specified in the By-laws of Club.
