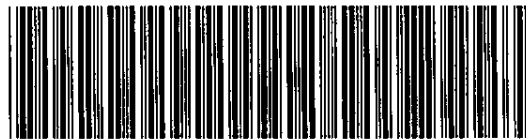

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I

The name of the corporation shall be:

Lien Mang Nguoi Viet Tu Do Toan Cau – Free Vietnamese Net World, Inc.

It is a Non Profit Organization, organized to be operated under 501(c)3 status.

ARTICLE III The “Lien Mang Nguoi Viet Tu Do Toan Cau - Free Vietnamese Net World” corporation is organized to facilitate contact and cooperation among the various Vietnamese community organizations, associations and individuals by formulating, organizing and coordinating programs aimed at:

- developing the economic, educational, cultural and social activities of the Vietnamese communities in the world;
- collecting and sharing information, knowledge, experience and initiatives;
- conducting researches on issues relevant to the building and growth of the global Vietnamese community;
- and in so doing, forming a network of Vietnamese communities, associations and individuals from various countries, promoting and maintaining the cooperation among its members to:
- to build and develop a strong global Vietnamese community;
- to preserve and develop the traditional values of Vietnamese culture;
- to serve the welfare of the worldwide Vietnam community;
- and to contribute to the development of a free, democratic and independent Vietnam and its territorial integrity.

ARTICLE IV

The property of this Corporation is dedicated to the purposes set forth herein and no part of the net income or assets of this corporation shall ever inure to the benefit of any Director, Officer, or Member thereof, or to the benefit of any private individual.

ARTICLE V

The Board of Directors shall be elected by vote in a General Meeting according to the By-Laws of Lien Mang Nguoi Viet Tu Do Toan Cau – Free Vietnamese Net World, Inc.

ARTICLE IX

Upon the dissolution or winding up of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a non-profit fund, foundation, or Corporation organized and operated exclusively for a purpose which has established its tax-exempt status under Section 501(c) 3 of the Internal Revenue Code.

ARTICLE X

These Articles of Incorporation may be amended by amendment approved by a majority vote of the Directors of this Corporation at any meeting of the Directors of the Corporation, provided that if the meeting is other than a regular meeting of the Corporation, notice of the meeting and the proposed amendment shall be served upon all Directors of the Corporation at least 10 days before the meeting, at which the amendment is proposed.

ARTICLE XI

The Corporation shall not engage in any activities which would disqualify it as a tax exempt organization under the United States Internal Revenue Code. It is the policy of this corporation not to discriminate, and the corporation shall not discriminate against anyone on any basis which would violate any state or federal anti-discrimination laws.

ARTICLE XII

This Corporation shall not, as a substantial part of its activities, participate in any political campaign on behalf of any candidate for public office.
