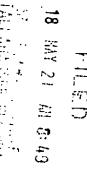

Article IX Dissolution

Upon dissolution of the corporation, assets of the Corporation shall be distributed for one or more of the tax-exempt purposes
within the meaning of section 501(c)(3) of the Internal Revenue Service Code, or the corresponding section of any future

or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted
to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code,
or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible
under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
Article XI Amendments to Articles of Incorporation
This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation.
Amendments to the Articles of Incorporation must be adopted by an absolute majority vote of the Board of Directors at any
board meeting called for that purpose.
