First Amendments to the Articles of Incorporation

The Articles of Incorporation are hereby amended as follows:

Article IX (additional article) Dissolution

Upon the dissolution of the Buddhist temple of the Treasure Coast Inc all remaining assets will be used or distributed exclusively for exempt purposes, such as charitable, religious, educational, and/or scientific purposes.

Article X (additional article) Non Discrimination

The Buddhist Temple of the Treasure Coast does not and shall not **discriminate** on the basis of race, color, religion (creed), gender, gender expression, age, national origin (ancestry), disability, marital status, sexual orientation, or military status, in any of its activities or operations.


