Articles of Amendment to Articles of Incorporation

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

Amendments Adopted

Please amend Article 3 to read as follows:

Article III. Purpose.

The specific purpose for which the corporation is organized is to be a faith-based community development organization serving our local community by engaging in a broad range of strategies that promote community health, education, and development, provide administrative and spiritual oversight and direction for other organizations which will themselves be organized and operated exclusively for educational, charitable, and/or religious purposes within the meaning of Section 501(c)(3) and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c)(3) of the Internal Revenue Code. This corporation is organized and operated exclusively for charitable and religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or to any corresponding provision of any future federal tax law.




