

Article VII. Purpose

This Corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal
Revenue Code of 1986 (hereinafter the "Code") pursuant to the provisions of Chapter 617 of Florida Statutes Annotated,
known as the Corporation Not for Profit, and laws amendatory thereto, as enacted or hereinafter amended, including, for
such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of
the Code, or the corresponding section of any future federal tax code. There shall be no capital stock issued, and this
corporation is not organized for profit, nor shall any person or member derive any benefit whatsoever, nor shall any
pecuniary profit or benefit inure to the members of this corporation, except that the corporation shall be authorized and
empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of
the purposes as described in Article VII.
Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage
in any activities or exercise any powers that are not in furtherance of the purposes of this corporation, or is not permitted
to be carried on by a corporation exempt from federal income tax under section 50l(c)(3) of the Internal Revenue Code,
or corresponding section of any future federal tax code.
Specific Objectives and Purpose.
The purpose of this corporation shall be to establish and maintain a church modeled after the early Biblical, Christian
community as recorded in the Acts of the Apostles, for the advancement of the Gospel of Jesus Christ by all available means,
in local, national and international communities, and to provide Christian fellowship for those of like faith where Jesus
Christ may be honored and glorified.
