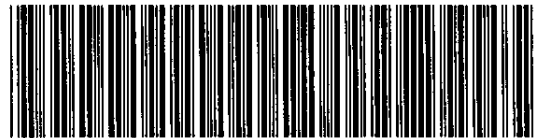



ARTICLE I

**Name.** The name of the corporation shall be THE RANDY JONES MEMORIAL FOUNDATION, INC.

ARTICLE II

**Address of Principal Office.** The principal office of the corporation shall be 3 Willow Place, Ocala, Florida 34472.

ARTICLE III

**Purposes.** This corporation is organized to provide fire fighting equipment and fire fighting education for fire departments in the Dominican Republic.

ARTICLE IV

**Election of Directors.** The method of election of Directors shall be that any member in good standing may nominate him or herself or any other member of the Board of Directors at least three (3) months prior to the annual meeting.

ARTICLE V



**Name and Address of Incorporator.** The Incorporator's name name and address are Randy Jones, 3 Willow Place, Ocala, FL 34472.

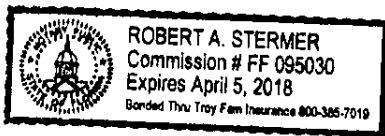
**ARTICLE VII**

**Distribution of Assets.** Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable and educational purposes as an exempt organization or organizations under Section 501 (c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as such Court shall determine, which are organized and operated exclusively for such purposes.
