TO THE
ARTICLES OF INCORPORATION
OF
TWO STEPS FURTHER PRIVATE FOUNDATION, INC.
A Florida Not for Profit Corporation**

Pursuant to Section 617.1006, Florida Statutes, this Florida Not for Profit Corporation desires to amend its Articles of Incorporation having been filed with the Florida Secretary of State under Document Number N17000002091 (collectively the "Articles of Incorporation").

1. Article One of the Articles of Incorporation is deleted in its entirety, and a new Article One is hereby inserted in its place, which new Article One shall read as follows:

**ARTICLE ONE
Name**
