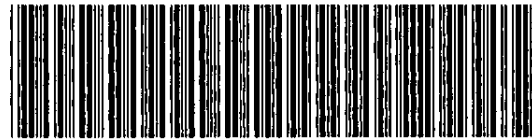

ARTICLES OF INCORPORATION
OF
KNIGHTS OF THE KINGDOM MINISTRIES, INC.

A Florida Not for Profit Corporation
In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, for the purpose of forming a Florida Not for Profit corporation under the laws of the State of Florida, Florida Statutes 617, hereby adopts and executes the following Articles of Incorporation.

ARTICLE I

The name of this corporation is **KNIGHTS OF THE KINGDOM MINISTRIES, INCORPORATED** – a Florida corporation Not for Profit.

ARTICLE II

The principal place of business and address of this corporation shall be:

Poinciana, Florida 34759

ARTICLE III

The Corporation is organized exclusively for charitable, religious, and educational purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The specific purposes of the Corporation are to establish and maintain a sovereign ministry dedicated to providing relief to the poor, the distressed, and the underprivileged by engaging in activities which will promote education, economic, health and human service needs in accordance to the word of God.

The Corporation shall not be conducted or operated for profit and no part of the net earnings of the Corporation shall inure to the benefit of any individual, nor shall any of the profits or assets of the Corporation be used other than for the purposes of the Corporation.

ARTICLE IV

The corporation shall have no members. The management of this corporation shall be vested in a Board of Directors. The number of directors and the method of selecting shall be fixed by the Bylaws of this corporation; provided that the initial directors shall be three (3) nor more than seven (7).

ARTICLE V

No officer or director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the officers or directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE VI

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of the section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are operated exclusively for such purposes.


ARTICLE VIII


