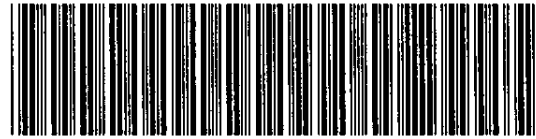

**ARTICLES OF INCORPORATION FOR
JONESVILLE CROSSING SOUTH, INC.**

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation. The effective date of these Articles is March 1, 2017.

**ARTICLE I
NAME OF CORPORATION**

The name of the corporation is: Jonesville Crossing South, Inc. (the "Association").

**ARTICLE II
LOCATION OF CORPORATION**

**ARTICLE III
PURPOSE OF CORPORATION**

The purpose for which this corporation is organized is to provide for the improvement, maintenance, preservation, and architectural control of property and improvements owned or controlled by the Association consistent with recorded covenants, restrictions, and water management district rules.

**ARTICLE IV
ELECTION OR APPOINTMENT OF DIRECTORS**

Once MCH, Inc. no longer owns any of the lots depicted in Exhibit A, the Board of Directors shall be elected by the members for one (1) year terms.

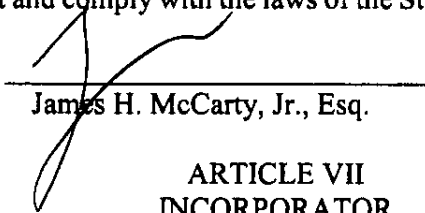

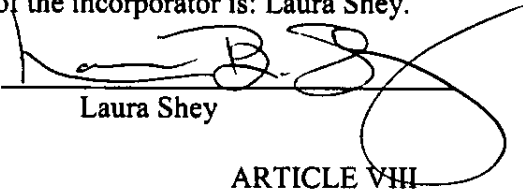

Corporate existence of the Association shall commence upon the filing of these articles with the Florida Department of State.

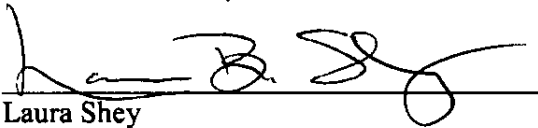
ARTICLE IX POWERS OF CORPORATION

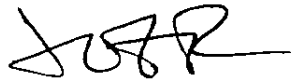

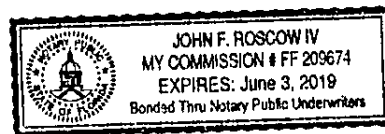
