**Article III is hereby amended as follows:**

This corporation is organized exclusively for charitable and religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law), including, but not limited to working to create community relationships with like-minded agencies for the good of tourists and the hospitality community.

**Article VIII is added as follows:**

Upon the dissolution of the corporation, after paying or making provision for payment of all the liabilities of the corporation, all of the remaining assets of the corporation shall be distributed exclusively for the purposes of the corporation in such manner, or to like organization organized and operated exclusively for charitable purposes as shall at the time qualify as an organization exempt from Federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

**Article IX is added as follows:**

- A. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
- B. No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the corporation set forth in Article III.

**Article X is added as follows:**

---

The corporate powers of this corporation are as provided in section 617.0302 Florida Statutes, except that the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

**Article XI is added as follows:**

The corporation shall have a racially nondiscriminatory policy and shall not discriminate against directors, employees, applicants, and others on the basis of race, color, or national or ethnic origin.
