# ARTICLES OF INCORPORATION OF DAY TOWN VOLUNTEER FIRE DEPARTMENT, INC.

The undersigned, for the purpose of forming a nonprofit corporation under Chapter 617, do hereby make and adopt the following Articles of Incorporation:

# ARTICLE I.

# NAME AND ADDRESS

The name of this corporation is DAY TOWN VOLUNTEER FIRE DEPARTMENT, INC. The address for this corporation is 3087 N County Road, Mayo, Florida 32066.

#### ARTICLE II

#### NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Directors, or Officers, except to the extent permissible under law.

## ARTICLE III

#### DURATION

The duration of the Corporation is perpetual. In accordance with the laws of the State of Florida, the date when corporate existence shall commence.

#### ARTICLE IV

#### **PURPOSES**

The Corporation is organized and shall be operated exclusively for the following purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code:

- 1. To establish a volunteer fire department for the Town of Day, Florida.
- 2. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort or

nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income, principal and proceeds of such property, for any of the purposes set forth herein.

- 3. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- 4. This Corporation is not organized for any purpose contrary to Section 501(c)(3), Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

## **ARTICLE V**

#### LIMITATION

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, Directors, or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 4 (Purposes) hereof. No esubstantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any further federal tax code.

#### ARTICLE VI.

# <u>MEMBERS</u>

The Corporation shall have Voting Members who shall be elected (and may be removed) by the Board of Directors and shall have the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote. #### ARTICLE VII.

#### INITIAL REGISTERED OFFICE AND AGENT

## ARTICLE VIII

## INITIAL BOARD OF DIRECTORS

The management of the Corporation shall be vested in a Board of Directors. The number of the Directors constituting the initial Board of directors is three (3). The number of Directors may be increased or decreased from time to time accordance with the Bylaws, but shall never be less than three (3). The manner in which the directors are to be elected or appointment shall be specified in the Bylaws.

The Voting Members shall elect the Directors annually. The Bylaws may provide for ex officio and honorary Directors, and their rights and privileges. The name and address of each initial Director of the Corporation is as follow:

#### **AMENDMENT**

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and all rights and privileges conferred upon the Members, Directors and Officers are subject to this reservation. The Articles of Incorporation may be amended in accordance with the provisions of the laws of the State of Florida, as amended form time to time, unless more specific provisions for amendments are adopted by the Corporation pursuant to law.

## **ARTICLE XIII**

# INDEMNIFICATION

The Corporation shall indemnify each Office and Trustee, including former Officers and Directors, to the full extent permitted by the laws of the State of Florida.

# ARTICLE XIV

# NONSTOCK BASIS

This Corporation is organized on nonstock basis. This Corporation shall not issue shares of stock.

# ARTICLE IV

# **POWERS**

The Corporation shall have all of the common law and statutory powers of a corporation not for profit pursuant to the laws of the State of florida that are not in conflict with the terms of these Articles; provided, however, that notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any further Untied States Internal Revenue Code.
