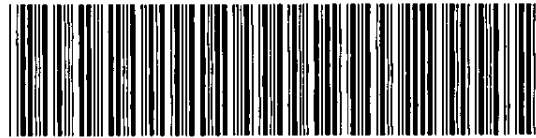



Article I – Name

The name of the corporation is: **IRCC Rifle and Pistol Club, Inc.**

Article II – Principal Office

The principal place of business and mailing address of the corporation is 1936 Freedom Drive, Melbourne, Florida 32940.

Article III – Purpose

The corporation is organized to provide education regarding the laws and responsibilities of firearm ownership to members of the club and residents of the Indian River Colony Club (IRCC); to provide members with opportunities for rifle, pistol, and shotgun shooting and training at lawfully approved ranges and venues; to encourage regular training and practice in the use of firearms; to emphasize and provide education on firearm safety and responsible firearm possession and use, and for other lawful and related purposes.

Article IV – Manner of Election of Officers and Directors

The manner in which directors and officers of the corporation are elected or appointed is provided in the bylaws of the corporation.

Article VII – Limitations

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, above.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) of the Internal Revenue Code or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article – VIII Dedication of Assets

Upon the dissolution, termination, or winding up of the corporation, the assets of the corporation shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any assets of the corporation not disposed of in this manner shall be disposed of by a Court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for exempt purposes, or to the organization or organizations that are organized and operated exclusively for exempt purposes, as determined by the Court.

Article IX – Initial Registered Agent and Street Address

The registered agent of the corporation is Donald Warhurst and the address of the registered agent is 1452 Goldrush Avenue, Melbourne, Florida 32940.


