REFUGE FOR WOMEN EMERALD COAST INC., a Florida corporation not for profit under the provisions of Chapter 617, *Florida Statutes* (the "Corporation"), hereby files these Articles of Dissolution evidencing the Corporation's dissolution and discontinuation of business, and sets forth the following pursuant to the provisions of Section 617.1403, *Florida Statutes*:

1. The name of the corporation is REFUGE FOR WOMEN EMERALD COAST INC.
2. The Corporation was formed effective on March 10, 2017, and was assigned document number N17000002661, and federal tax identification number 26-4388243.
3. The Corporation has no members or no members with voting rights.
4. The Board of Directors of the Corporation adopted, by written consent of all of the Corporation's directors in accordance with Section 617.0821, *Florida Statutes*, a resolution to dissolve the corporation.
5. The action by written consent described in Paragraph #4. of these Articles of Dissolution was effective as of 11/19/18.
6. The Dissolution of the Corporation is effective upon filing of these Articles of Dissolution with the Secretary of State.

1. The name of the Corporation is REFUGE FOR WOMEN EMERALD COAST INC. (the "Corporation").


2. The date of dissolution of the Corporation will be the date the Articles of Dissolution are filed with the Department of State of the State of Florida.
