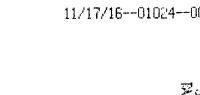

# ARTICLE VIII DISSOLUTION OF CORPORATION AND DISTRIBUTION OF ASSETS

Section 1. <u>Dissolution</u>. No part of the net income, revenue, and grants of the Corporation shall inure to the benefit of any member, officer, or any private individual (except that the reasonable compensation may be paid for any services rendered in connection with one or more of its purposes), and no member, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any part of the assets of the Corporation. In its dissolution or liquidation, the assets and the records for the Corporation, after payments of debts and obligations, shall be transferred to an organization with federal tax exemption for charitable and educational uses and purposes similar to those of the Corporation or to a state or local government, for public purposes. The Exempt organization shall be designated by the final Board of Directors of the Corporation.

Section 2. <u>Distribution of Assets</u>. The affirmative vote of two-thirds of the Directors of the Corporation at any annual meeting of Directors or special meeting of Directors shall be required to adopt or approve the distribution of the Corporation. The notice of the meeting, at which any such action is to be considered, shall set forth the subject of the action or actions to be approved.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate. I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
