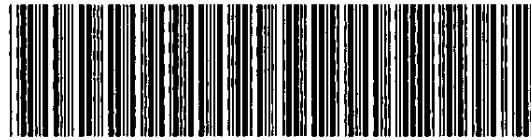

Dissolution Clause
