ANMEMDED ARTICLES OF INCORPORATION

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

ARTICLE I NAME

1.01 Name

The name of this corporation shall be *Buds For Vets Inc.*

ARTICLE II DURATION

2.01 Duration

The period of duration of the corporation is perpetual until dissolution.

ARTICLE III PURPOSE

3.01 Purpose

Buds For Vets Inc. is a non-profit corporation and shall operate exclusively for educational and charitable purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Buds for Vets is a Florida non-profit organization dedicated to the support and advocacy dedicated to connecting, supporting, educating, and advocating Veterans with alternative treatment particularly cannabis to improve their quality of life. Our purpose is to provide a welcoming safe space, and a sense of community for those who have served our country by educating and supporting veterans who suffer with conditions ranging from inescapable PTSD to chronic pain of physical injuries.

We help our veterans who are seeking to use plant-based medicine, while under a doctor's care as risk reduction therapy and a natural alternative to opioids. In addition, we raise money to pay for the state fee for all veterans- in providing for free the first Medical Marijuana doctors' visits to Veterans 70% or more disabled. At *Buds For Vets Inc.*, we focus on a holistic approach to the health and well-being of Veterans that empowers them through their journey of healing.

The organization will engage in activities permissible under section 501(c)(3) including but not limited to:

- 1. Provide a safe space and welcoming environment for vets to connect to learn about the benefits of alternative therapies such as cannabis.
- 2. Provide education, information and safe access to resources, benefits, housing, employment, and networking opportunities to create a sense of community to support our veterans.
- 3. Offer and provide veterans the resources to begin the process of applying for a medical cannabis referral card, free cannabis medicine and/or low-cost referrals to veterans.
- 4. Provide education about cannabis medicine and create a sense of community for our veterans to alleviate stigma through furthering education on cannabis.
- 5. Provide readily accessible resources to our veterans to understand the value of medical cannabis and their rights.
- 6. Advocate and collaborate work with local and state governments, and other organizations to ensure the voice of our veteran community is heard and their needs are taken into consideration.
- 7. Provide education and resources to veterans about state cannabis programs, cultivation practices, processing techniques, and consumption methods.

8. Provide support and expand access to cannabis medicine for veterans to reduce opioid dependency.

9. Expand access to cannabis medicine through policy reform as well as lowering costs of cannabis medicine and home growing.

Notwithstanding anything herein to the contrary, the purposes of this corporation are limited exclusively to exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

3.02 Non-Profit

Buds for Vets Inc. is designated as a non-profit corporation.

ARTICLE IV NON-PROFIT NATURE

4.01 Non-profit Nature

Buds For Vets Inc. is organized exclusively for charitable and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of Buds For Vets Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

No substantial part of the activities of *Buds For Vets Inc.* shall constitute the carrying on propaganda or otherwise attempting to influence legislation or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Buds For Vets Inc. is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

4.02 Personal Liability

No member, officer or director of this corporation shall be personally liable for the debts or obligations of *Buds For Vets Inc.* of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

4.03 Dissolution

Upon termination or dissolution of the Buds For Vets Inc., any assets lawfully available for distribution shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent exclusively for such purposes or to such organization or organizations, as said Court shall finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

4.04 Prohibited Distributions

No part of the net earnings or properties of this corporation, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, Section 3.01.

4.05 Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

4.06 Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an

organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future

ARTICLE V BOARD OF DIRECTORS

5.01 Directors and Manner of Election

Buds For Vets Inc. powers of the Corporation shall be exercised by or under the authority of, and the affairs of the Corporation shall be managed under the direction of, a Board of Directors, the number of which may be either increased or decreased from time to time as regulated by the Bylaws but shall consist of not fewer than three. The manner and method of election of the Board of Directors shall be as stated in the Bylaws of the Corporation.

ARTICLE VI **MEMBERSHIP**

6.01 Membership

Buds For Vets Inc. shall have no members. The management of the affairs of the corporation shall be vested in a board of directors, as defined in the corporation's bylaws.

ARTICLE VII **AMENDMENTS**

7.01 Amendments

Except as provided, any one or more of the provisions of these Amended Articles of Incorporation may be amended in accordance with the requirements of the Florida Statutes and the Bylaws of


